XIII. SUMMARY RECORD OF THE SIXTH GENERAL MEETING (CONCLUDING SESSION) HELD ON FRIDAY, 6TH JULY 2007 AT 6:30 PM

Her Excellency Mrs. Brigitte Sylvia Mabandla, President of the Forty-Sixth Session in the Chair.

1. The **President** formally called to order the Sixth General Meeting. She invited the Delegates of Uganda, Republic of Indonesia, Lesotho and UNEP to propose a vote of thanks on behalf of the African, Asian, Non-Member Observer States and Intergovernmental Organizations respectively participating in the Forty-Sixth Session of AALCO.

2. Statement by the Leader of Delegation of Uganda on behalf of the African Member States

Let me tell you that we in AALCO, this Organization, to me the unity I found here, the love should be maintained and it should be broadened. And that also reminds me that two fellows went in to national park, when they started walking, a lion approached them and one of them started putting up his running gumboots to begin taking off. The other fellow said you must be dumped, who said you can leave the lion, can you run faster than the lion. And the other one said who says I want to leave the lion, I want to leave you.

Madam President, We are committed to the resolutions of this meeting, we are committed to their implementation, and we are committed to continuing the work together in solidarity. Thank you so much.
