RESOLUTIONS ON ORGANIZATIONAL MATTERS

RES/45/ORG 1 8 APRIL 2006

REPORT OF THE SECRETARY GENERAL ON ORGANIZATIONAL, ADMINISTRATIVE, AND FINANCIAL MATTERS

The Asian-African Legal Consultative Organization at its Forty-Fifth Session,

Conscious of the functions and the purposes of the Organization as referred to in Article 1 of the Revised Statutes,

Having considered the Report of the Secretary-General on Organizational, Administrative and Financial Matters pursuant to Rule 20 (7) of Statutory Rules as contained in Document No. AALCO/45/HEADQUARTERS SESSION (NEW DELHI) /2006/SD/ORG 1,

Appreciating the efforts of the Secretary-General to enhance the activities of the Organization and to implement its work programme as approved at its Forty-Fourth Session in Nairobi,

Bearing in mind that 2006 marks the fiftieth anniversary of AALCO,

Welcoming the continued practice towards the rationalization of its work programme, including consideration of the agenda items during its annual sessions,

1. **Expresses its satisfaction** over the increasing co-operation between the Organization and the United Nations, its Specialized Agencies and other Intergovernmental Organizations;

2. **Approves** the work programme of the Organization for the year 2006 as set out in the Report of the Secretary-General and urges Member States to extend their full support to the implementation of that programme;

3. **Requests** the Secretary-General to continue his efforts to enlarge the Membership of the Organization including Central Asian States, South-East Asian States and French-speaking countries from both regions and to mobilize financial resources to have French as an additional working language during the coming sessions;

4. **Encourages** Member States to make voluntary contributions to support the organization of seminars/meetings or to conduct projects on any specified topic under the approved work programme of the Organization;

5. **Thanks** the Government of India for its generous financial support in the convening of the Headquarters Session:

6. **Requests** the Member States to make suggestions to the Secretary-General on the commemoration of the ongoing Golden Jubilee celebrations of the Organization and urges them to cooperate in this great event through voluntary contribution; and

7. **Also commends** the initiative of the Secretary-General in inviting experts and scholars of international law to contribute articles for the proposed commemorative volume of Essays in International Law to be released during the Golden Jubilee Year;

8. **Requests** the Secretary-General to report on the activities of the Organization at its Forty-Sixth Session.

AALCO'S BUDGET FOR THE YEAR 2007

The Asian-African Legal Consultative Organization at its Forty-Fifth Session,

Taking note of the proposed budget for the year 2007 contained in Document No.AALCO/45/HEADQUARTERS SESSION (NEW DELHI)/2006/SD/ORG 2,

Recalling operative paragraph 3 of the RES/44/ORG 2 of 1 July 2005 adopted at the Forty-Fourth Session held in Nairobi,

Appreciating the efforts of the Secretary-General towards economizing the expenditure and the optimum utilization of the finances of the Organization,

Expressing serious concern about the increasing arrears due to non-payment of annual contributions by some Member States,

Takingintoaccounttherecommendationonbudgetaryproposalsforthe year2007adopted at the 290^{th} Meeting ofthe LiaisonOfficerson 28^{th} February2006,

Taking into account, also, the fact that the Scale of Contributions did not change since 1993,

1. **Approves** the Budget for the year 2007 as proposed;

2. **Requests** Member States to pay their contributions for the year 2007 as soon as possible in accordance with their budgetary system;

3. **Urges** those Member States who are in arrears to fulfill their financial obligations and to clear expeditiously the same and in order to enjoy the right to get involved actively in various official events stipulated in AALCO's current Statutes and Statutory Rules;

4. **Also urges** those Member States who are facing financial difficulties in defraying their annual contributions due to conditions beyond their control to furnish to the Secretary-General detailed information on those financial difficulties; and

5. **Agrees**, upon the request of Somalia and the comprehensive explanation of the Secretary-General related to the great justified financial difficulties of Somalia, to waive all its arrears and dispense Somalia from paying its contributions until it is in a position to do so.

6. **Requests** the Secretary-General to prepare in consultation with Liaison Officers a draft revised Scale of the Contributions to match with the continuous rise of the living cost in general and the expected increase in the Secretariat's running costs after the shifting to the new Permanent Headquarters Building;

7. **Also requests** the Secretary-General to follow-up, within Budgetary Advisory Panel of Liaison Officers and in the Meetings of Liaison Officers, to find concrete measures to solve the aforesaid issues, mainly the problem of arrears and to report on the implementation of this resolution at its Forty-Sixth Session.

Acknowledges the request from Somalia to waive its arrears and dispense it from making annual contribution due to financial difficulties arising out of condition beyond its control,

Having heard the elaborate statement of the Secretary-General regarding the great financial difficulties of Somalia,

1. **Decides** to waive all arrears of Somalia;

2. **Also decides** to dispense Somalia from making annual contribution until decided otherwise.

PROGRESS REPORT ON AALCO'S REGIONAL CENTRES FOR ARBITRATION

The Asian-African Legal Consultative Organization at its Forty-Fifth Session,

Having considered the Progress Report on AALCO's Regional Centres for Arbitration contained in Document No. AALCO/45/HEADQUARTERS SESSION (NEWDELHI)/2006/ORG 3,

Reaffirming the commitment by the governments of Member States towards enhancing the role of the Regional Arbitration Centres,

Recalling its decision relating to the Integrated Scheme for the Settlement of Disputes in Economic and Commercial Transactions adopted at its Doha Session in 1978,

Expressing its satisfaction over the increasing use of the facilities and the opportunities offered for both domestic and international arbitrations under the auspices of its Regional Arbitration Centres,

Welcomes the proposal for the establishment of the fifth AALCO's

Regional Arbitration Centre in Nairobi, with the cooperation and financial assistance of the Government of the Republic of Kenya,

Also welcomes the establishment and inauguration of the Advisory Committee of the Regional Centre for International Commercial Arbitration, Lagos on February 7, 2006,

1. Appreciates the efforts and contributions of the Governments of the Arab Republic of Egypt, the Islamic Republic of Iran, Malaysia and Nigeria for hosting the respective Regional Arbitration Cenfres;

2. **Also appreciates** the promotional activities undertaken by the Directors of the Centres, including organization of seminars and training programmes, to promote international commercial arbitration in the Asian and African regions;

3. **Reiterates** the earlier decision of the AALCO on the necessity for the governments of Member States to promote and support the use of the Regional Arbitration Centres;

4. **Also reiterates** its proposal that after consultation with the Directors of the respective Regional Arbitration Centres, the holding of International Arbitration Conference biennially, by rotation in each of the four Arbitration Centres, with the support of Member States;

5. **Welcomes** the Agreement and MOU signed between the AALCO and the Government of the Republic of Kenya for the Establishment of the Regional Centre for Arbitration in Nairobi on 3 April 2006;

6. **Requests** the Secretary-General of AALCO, in cooperation with the Government of the Republic of Kenya, to facilitate the implementation of the Agreement and MOU for the establishment of the Nairobi Regional Arbitration Centre; and

7. **Decides** to place this item on the provisional agenda of its Forty-Sixth Session.

RES/45/ORG 4 8 APRIL 2006

AALCO'S CENTRE FOR RESEARCH AND TRAINING

The Asian-African Legal Consultative Organization at its Forty-Fifth Session,

Having considered the report of the Secretariat on the AALCO's Centre for Research and Training (CRT), contained in Document No. AALCO/45/HEAD-QUARTERS SESSION (NEWDELHI)/ 2006/ORG 4,

Recognizing the need and importance of the exchange of information among AALCO, its Member States, the United Nations and its Specialized Agencies, and other International Organizations for improved capacity-building and enhancement of legal expertise in areas of international law,

Bearing in mind the effective role of research and training in promoting the objectives of the Organization,

Also bearing in mind a more proactive role the Centre could play in furthering the mandate of the Organization in making best use of the new Headquarters Building equipped with modern technology and infrastructure facilities,

Appreciates the efforts of the Secretariat in preparing special studies on matters of common concern and its plan to hold training programmes in cooperation with Inter-governmental Organizations and to ensure financial support to these programmes, Also appreciating the efforts of the Secretariat towards the continuous upgrading of the Organization's website,

1. **Requests** the Secretariat to maintain, update and improve the technical efficiency of the website for facilitating communication between the Secretariat, the Member States, the United Nations and its Specialized Agencies, and other International Organizations;

2. **Also requests** the Secretary-General to foster capacity-building of the Centre to carry out further research projects on international law and to organize training programmes for the benefit of the officials of Member States handling international law issues;

3. **Urges** Member States to furnish information and other relevant materials in order to enhance the activities of the Centre for Research and Training (CRT);

4. **Decides** to establish a "Research and Training Fund" in the Golden Jubilee year of AALCO, exclusively to promote and strengthen Research and Training under the CRT, to which voluntary contributions could be made by the Member States, with a view to providing a sustainable financial basis to the Centre to undertake its mandated activities;

5. **Directs** the Secretariat to take necessary measures to promote the awareness about the Centre so that the services available in the Centre would be made use of by the public and private sectors in the Member States;

6. **Requests** the Secretary-General to explore the possibility of establishing an annual legal training fellowship programme for legal officers from Member States of the Organization, on selected fields of international law, and to report to the Forty-Sixth Session on the feasibility as well as the administrative and financial implications of the establishment of the programme; and 7. **Also requests** the Secretary-General to report on the progress made in the work of the Centre for Research and Training at its Forty-Sixth Session.
