and exhaustive analysis of a large number of multilateral constitutive covenants, plurilateral instruments as also numerous resolutions of the General Assembly. In addition to the foregoing, the process of identification of the elements of friendly and good neighbourly relations would also entail and involve numerous bilateral treaties. The list of existing international instruments, including resolutions of the General Assembly recourse to which may be had in the process of identifying, enumerating and developing the principles and norms to be included in the proposed international instrument may be found in Section C of this note. A short list of bilateral agreements on amity peace, good-neighbourly relations and mutual cooperation is also included in that section.

Finally it may, be stated that an item entitled "Development and Strengthening of Good Neighbourliness Between States has been on the agenda of the General Assembly since its Thirty-sixth Session (1981).¹¹ Earlier, the General Assembly had at its XVIII¹² and XXth session¹³ considered an item entitled "Actions on the Regional Level with a view to improving Good-Neighbourly Relations among European States having different Social and Political Systems". Simultaneous consideration of the elements of friendly and good neighbourly relations by the Sixth Committee of the General Assembly and the AALCC would, while complimenting the endeavour of the other, help usher in international peace, security and stability.
