As a senior jurist, Dr. Gastorn has been devoted to increasing AALCO's activity, visibility and influence since he took office as Secretary General. Our thanks also go to the newly appointed Deputy Secretary General Madame Wang Liyu from China for her efforts to facilitate the donation process.

AALCO quite unique, because the only is it is inter-governmental legal organization in the world that covers Asia and Africa. AALCO is very important, because it is a platform for Asian and African countries to participate in international legal cooperation and reflect the aspirations and common interests of developing countries. AALCO is full of expectation, because it inherits and develops the Bandung Spirit of "solidarity, friendship and cooperation", and plays an active role in promoting world peace and development as well as fairness and justice.

This year marks the 40th anniversary of China's reform and opening-up. China owes its success to the world. A year ago in the small town of Davos, Switzerland, President Xi Jinping called for determined efforts to develop global free trade and

investment, promote trade and investment liberalization and facilitation in the opening up, and oppose protectionism in a clear-cut manner. Presiden Xi also pointed out that we should uphold multilateralism, safeguard the authority and effectiveness of multilateral institutions, and build a fair and equitable governance model. Recently, the US initiates Section 301 investigation against China. In this context, President Xi's proposals stand more prominent rather than dilute.

In the recent concluded Boao Forum for Asia, President Xi announced that China's door to the outside would not shut but only open wider, and proclaimed significant measures for China's further opening-up. The Belt and Road Initiative was put forward 5 years ago. Since then, it has become the largest international cooperation platform in line with the trend of economic globalization. The Belt and Road Initiative originated from China, but its opportunities and achievements belong to the world.

Most of the 47 Member States are countries along the Belt and Road. AALCO could build a platform for legal cooperation

with regard to the Belt and Road Initiative, and play a bigger role in trade and investment dispute mediation and arbitration. We are also looking forward that AALCO would make the best of its unique and important position to improve global governance in the international law, promote a more just and equitable international order, and uphold the sovereignty and development interests of Asian and African countries.
