The Asian-African Legal Consultative Organization [AALCO], an inter-governmental Organization consisting of 47 Member states from Asia and Africa, was established on 15<sup>th</sup> November 1956 with its Headquarters in New Delhi, India. It serves its Member states as an advisory body, and as a forum to facilitate the exchange of views and information on legal matters of common concern to its Member States. The Centre for Research and Training [CRT], which was established in 1989 under the auspices of AALCO, has been providing training, technical assistance and facilitating capacity building programmes with a view to enhance legal expertise in international law in the Asian-African region. In the process it has also brought out a number of publications on topics of contemporary relevance and has conducted Seminars, Workshops and Training Programmes on various topics of international law.

On the Current Training Programme on Trade and Development Issues: A Training Programme on Trade and Development Issues is being organized with the active support and cooperation of WTO Headquarters, Geneva and Centre for WTO Studies, IIFT, New Delhi. The objective of this Programme is to understand the problems/issues confronting the Developing States in relation to the Doha Development Round of the WTO.
