APPOINTMENT OF THE SECRETARY-GENERAL

I. Introduction

1. It may be recalled that at AALCO's Fifty-Fifth Annual Session held in New Delhi (India), from 16 to 20 May 2016, H.E. Prof. Dr. Kennedy Gastorn, the current Secretary-General from the United Republic of Tanzania was unanimously elected¹ as Secretary-General of AALCO, for a term of four years commencing from 15 August 2016² and ending on 14 August 2020.

II. Appointment of the next Secretary-General of AALCO during the Fifty-Ninth Annual Session of AALCO

2. The Secretariat announced to the Member States that in accordance with Rule 20 of the Statutory Rules of AALCO, the "Election and Appointment of the new Secretary-General" shall be one of the agenda items in the upcoming 59th Annual Session as per the Note Verbale No. 431/2019 /SGE/AALCO of 26 November 2019. However, due to COVID-19, the Fifty-Ninth Annual Session was postponed and as a result, it was announced that for the effective and smooth functioning of the Secretariat during this period, H. E. Prof. Dr. Kennedy Gastorn will continue to carry out his duties and functions in line with practice and in accordance with AALCO Statutes and Rules as the Secretary-General until the election (vide No.106/2020/SS/AALCO of 1 June 2020). As the Fifty-Ninth Annual Session is scheduled to be held in Hong Kong SAR, the People's Republic of China, from 29 November to 1 December 2021, the "Appointment of the Secretary General" is to take place during the Second Meeting of Delegations, on 29 November 2021. Thereafter, the President of the Fifty-Ninth Annual Session will declare the outcome of the decision taken at the Plenary Meeting.

III. Provision concerning the Appointment of the Secretary-General

3. The provision governing this issue as stipulated in Rule 20 (1) of the AALCO Statutory Rules is as follows:

"20. The Secretary-General

(1) The Organization shall appoint a legal expert or a person who has adequate legal expertise and administrative experience, who is a national of a Participating State, to be Secretary-General, for a term of four years. The person so appointed shall be eligible for re-appointment for only one further term of four years.

The appointment of the Secretary-General which shall be based on rotation between the two regional groups, shall be by consensus of the Participating States.

In the event that consensus cannot be reached after all efforts have been exhausted, an indicative secret ballot by majority at the meeting of the Heads of Delegations may be used to offer a consensus candidate who will be appointed by the Organization.”

4. The Secretariat invited nominations for the post of Secretary-General from Member States vide Note Verbale No. 431/2019/SGE/AALCO dated 26 November 2019. Within the set deadline, the Secretariat has received two nominations for the post of the Secretary-General from the Asian region. The first candidature, nominated by the Royal Thai Government³, along with the C.V. of Dr. Kamalinne Pinitpuvadol, was duly notified to the Member States, by the Secretariat on 27 July 2020. The second nomination was received from the Government of the Syrian Arab Republic of Mr. Ammar Bilal whose CV was notified to the Member States by the Secretariat on 24 September 2020.

IV. Procedure for the Election of the Secretary-General

5. The primary method of appointment of a candidate as Secretary-General is by consensus. However, in the event that consensus cannot be reached after all efforts, the election of the Secretary-General will take place according to the following procedure based on Rule 20 (1) of the AALCO Statutory Rules and past practice.

- a. The election is done by an indicative secret ballot.
- b. In case there is only one candidate, a majority of Member States present and voting is required for him/her to become the consensus candidate.
- c. In accordance with the past practice, a Committee would be constituted to count the votes. It will comprise of the Secretary-General, Deputy Secretaries-General and one member from the candidate's Delegation. The Committee will inform the President of the result. Thereafter, the President will finally declare the result⁴.
- d. During the Fifty-Ninth Annual Session of AALCO, this item will be deliberated during the Second Meeting of Delegations of the Member States with the presence of the Heads of Delegations at this meeting being of utmost importance.⁵

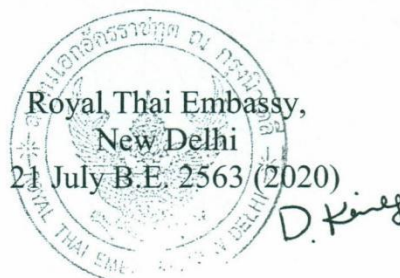

Curriculum Vitae

Dr. Kamalinne Pinitpuvadol



BACKGROUND

Born in Bangkok on August 17, 1958, Dr. Kamalinne Pinitpuvadol held Bachelor's degrees in law from Chulalongkorn University (Bangkok, Thailand), Master's degrees in international law (Diplôme d'études approfondies or DEA) from the Université Robert Schuman, also known as Strasbourg III, and obtained a Doctorate in international law (Docteur en Droit) in 1991 from the University of Strasbourg (the French Republic).

He started his career as a lecturer at the Faculty of Law of Chulalongkorn University in 1991 where he taught and researched in the areas of private international law, international investment law, international trade law, international economic law, international law on children's rights and European Union law. In addition to his legal expertise, he was appointed as the Executive Director of Child Rights ASIANET, a regional center founded by the Faculty of Law, the International Law Association of Thailand (ILAT) and the United Nations Children's Fund for East Asia and the Pacific (UNICEF/EAPRO), which aimed to promote and protect rights of children in Asia and the Pacific. He held the position of Secretary General of the International Law Association of Thailand and led the preparation of the Thailand Journal of International Law. He also held the position of Associate Judge at the Central Intellectual Property and International Trade Court.

He joined the Eastern Asia University in 2003 as Vice President for Research Affairs and Director of Master Program on Business Law. From 2008 to 2014, he served as Deputy Executive Director at the Knowledge Network Institute of Thailand, Ministry of Education, an organization engaging with public policy focusing on higher education. He also held the position of Director of the Institute of Good Governance for universities.

In 2015, he was elected and appointed to the position of the Executive Director of the International Institute for Trade and Development (ITD) (Public organization)¹. His term ended in January 2019. During his office for the term of four years, Dr. Kamalinne Pinitpuvadol has seen to fruition his work to revitalize and strengthen the organization, as well as his work in promoting and strengthening knowledge on various issues related to trade, investment and development through conferences, seminars, workshop, training programs and research programs. Under his leadership, ITD has also increased the scope of its engagements with other international and regional organizations. ITD has cooperated closely with UNCTAD, WTO, ITC, UNCITRAL, UNESCAP and ICSID. ITD has also embarked on several capacity-building and research programs with various national and regional organizations such as APEC, ASEAN, Asia-Pacific Research and Training Network on Trade (ARTNeT), Economic Research Institute for ASEAN and East Asia (ERIA), ASEAN Law Association (ALA), Asian Society of International Law (Asian SIL), CUTS International, Mekong Institute (MI), Economic Research Institute for Trade (ERIT) of Lao PDR, Institute of Malaysian and International Studies (IKMAS), Trade Training and Research Institute (TTRI) of Cambodia and Free Trade University (FTU) of Vietnam.

Currently, he holds the position of Advisor to the National Security Council - Thailand and Senior Legal Expert on international law at Department of International Economic Affairs, Ministry of Foreign Affairs. He represented Thailand in the meeting of UNCITRAL Working Group III (ISDS reform) in January 2020. He also holds the position of member of the Expert Committee of various organizations such as International Advisory Board of CUTs International, Committee on Children's rights of the Department of Children and Youth Affairs, Committee on Legal affairs of the Board of Investment, Foreign Affairs Committee of the Office of Trade Competition Commission, Academic and Research Committee of the Thailand Institute of Justice and Committee on the Executive Course on Thailand and ASEAN in the Global Political Economy of the College of Politics and Governance, King Prajadhipok's Institute. He still teaches occasionally at the Faculty of Law of Chulalongkorn University.
